- Know about the theoretical frontiers and developments related to international organizations;
- Comprehend the operational mode and logic as well as relevant regulations and principles of international organizations;

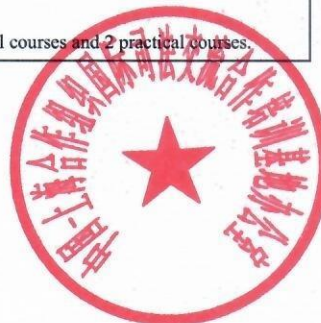

Transcript of Records (from undergraduate level onwards)	1	Scanned transcripts should include grades from the undergraduate and master's (if any) level of study up to the most recent semester. The transcripts should be issued and stamped by the university's Academic Affairs Office, Graduate School or relevant student administration department. It can be in Chinese or English.
Letter of Financial Support	1	The applicant should provide a letter of economic guarantee and a copy of the sponsor's ID.
Foreigner Physical Examination Form	1	Photocopy (please keep the original on your own, this form is uniformly printed by the Chinese Health and Quarantine Department and must be completed in English). The applicant should strictly follow the requirements of the items in the "Foreigner Physical Examination Form". The Foreigner Physical Examination Form with missing items, without the photo of the applicant or the stamp on the photo, or without the signature and stamp of the physician and the hospital is invalid, and the examination result is valid for 6 months.
Copy of the First Page of the Passport	1	If your current passport does not meet the requirements (valid for more than 6 months), please apply for a new passport immediately.
Passport Photo	1	Electronic version.
Certificate of No Criminal Record	1	A valid certificate of no criminal record issued by the local public security department, usually within 6 months of the date of submission of the application.
Study Plan for Coming to China	1	A study plan in English (with more than 1,000 words) should be submitted.
Letter of Recommendation (Chinese or English)	1	A letter of recommendation from the applicant's university, focusing on the applicant's goals for studying in China, the applicant's overall abilities, and future development. It can be written in Chinese or English.
<b>Notes: The materials uploaded through the system must be clear, authentic, and valid. It is recommended that applicants use professional equipment to scan the relevant files that need to be submitted. The applicant shall bear the consequences of unclear or unrecognizable materials.</b>

### V. Application Process

1. Log in to the “Online Application System for International Student of Shanghai University of Political Science and Law” and follow the steps below:
  - Log in to <http://admission.shupl.edu.cn/studentLogin>; select “Shanghe Youth” Advanced Trainee Program in the application category.
  - Fill in and submit the application information online.
2. Shanghai University of Political Science and Law will review the applicant’s materials. Applicants who pass the review will receive a formal letter of admission and visa application form (JW201 or JW202).
3. Applicants must present the formal letter of admission and visa application form (JW201 or JW202) to the relevant embassy or consulate in their country to apply for a visa to come to China, and come to the university to complete the registration procedures at the prescribed time.
