



CROSSING THE BORDER

- **Before entering the country**, it is required to inform the International Students and Faculty Department by mail (ISO@fa.ru) no later than 10 working days before arrival, and fill out the form (scan QR) to be included in the list of foreign students admitted to enter Russia. Please note that only students from countries whose borders with Russia are open can be included in the list!

- **While entering the country**, a PCR test for Covid is required, done no earlier than 72 hours before crossing the border. The test can be taken at the polyclinic of the Financial University or any other medical institution in Moscow (the test is paid)

- **After entering the country**, all students, regardless of whether they have a vaccination certificate, are required to re-pass the PCR test for Covid within 72 hours and submit the results to the Accommodation Office



STUDENT ARRIVAL ROADMAP

- Fill out a dormitory check-in application at the Admissions Office (Leningradsky Prospect 51/1, room 0222, 2nd floor)

- Obtain a Medical Insurance (in advance by QR code or at the the Admissions Office)

- With an application signed at the Admissions Office, come to the Accommodation Office (Leningradsky prospect 55, room 112, 1st floor)

- Draw up documents at the Migration and Visa Division. You will need a passport, a copy of your passport and a migration card with the mark "Study" as the purpose of entry. (Leningradsky prospect 51/1, room 0209, 2nd floor)

- Return to the Accommodation Office and get a direction to the dormitory

- Go to the designated dormitory at the specified address



LIST OF REQUIRED DOCUMENTS

- Notarized translation of the passport into Russian
- Notarized translation of an educational document
- Test for Covid (PCR), done no earlier than 72 hours before crossing the border
- At the border, get a migration card and CHECK the mark about the purpose of entry. There should only be "Study"
- + If you are going to live in a dormitory:
 - Medical certificate 086u or a similar document on a full medical examination (translation, if in foreign language) - Valid for 6 months
 - Certificate from a dermatologist (translation, if in foreign language) - Valid for 6 months
 - Certificate of absence of HIV (translation, if in foreign language) - Valid for 3 months
 - Medical Insurance - online registration is available (scan QR)
